  - Case comments (1000-3000 words).
3. The manuscript should be in MS Word format.
4. The manuscript shall be original and unpublished.
5. Authorship: Maximum of two authors per entry.
6. The author(s) must follow the uniform method of citation either Journal of Indian Law Institute (JILI) or Blue Book (20th Edition).
7. The body of the paper shall be in Times New Roman, font size 12, 1.5 line spacing. Footnotes should be in Times New Roman, size 10 single line spacing.
